# Research Ethics: Past, Present and Future VCU HRPP's Inaugural Annual Conference



The VCU HRPP held its inaugural annual conference on September 29, 2022. The conference had over 150 registrants, including VCU faculty, staff and students, as well as members of the research community from other academic institutions in the area.

The keynote address was presented by Michael Dickinson, Ph.D., Assistant Professor in the VCU Department of History and author of the book "Almost Dead: Slavery and Social Rebirth in the Black Urban Atlantic, 1680-1807," published in May 2022 by The University of Georgia Press.

Other conference sessions included a panel led by Dr. Kevin Allison, Professor of Clinical Psychology in VCU's Department of Psychology, a presentation by Dr. Lisa Merck, Professor and Vice Chair of Research at the VCU Department of Emergency Medicine, and a panel discussion featuring the research of Dr. Robin Everhart, Associate Professor in Health Psychology in the VCU Department of Psychology.

# Keynote Address: Dr. Michael Dickinson



Dr. Dickinson's keynote discussed his new book, "Almost Dead: Slavery and Social Rebirth in the Black Urban Atlantic, 1680-1807," and he read a powerful excerpt from it. He also discussed the interviews he conducted with descendents of Jeffrey Brace, the former West African slave and America Revolutionary War veteran who is the subject of his book.

The keynote address provided relevant historical context. This examination of the past provides an opportunity to reflect upon the importance of trust with research subjects and how those relationships can help facilitate the progression of science while building relationships with a marginalized community.

# Perspectives on Research and Ethics with LGBTQIA+ Individuals and Communities

Kevin Allison, Ph.D., facilitated a panel discussion, "Perspectives on Research and Ethics with LGBTQIA+ Individuals and Communities."

Panelists included Eli Coston, Ph.D., Assistant Professor in the VCU Department of Gender, Sexuality and Women's Studies; Julian K. Glover, Ph.D., Assistant Professor in the VCU Department of Gender, Sexuality and Women's Studies; and Alex Wagaman, Ph.D., Associate Professor in the VCU School of Social Work.

A rich discussion ensued, as panelist shared their experiences with research studies that have informed their perspectives on conducting ethical research with LGBTQIA+ communities and participants. Panelists also discussed what they see as some of the most important issues and considerations in engaging LGBTQIA+ communities and participants in research from the lens of ethics.

## **Exception from Informed Consent (EFIC)**

Lisa Merck, MD, Professor and Vice Chair of Research at the VCU Department of Emergency Medicine, spoke about Exception from Informed Consent (EFIC) research.

EFIC investigations are conducted with human subjects with a life-threatening medical condition that necessitates urgent intervention for which available treatments are unproven or unsatisfactory, and who cannot provide informed consent due to their condition (e.g., traumatic brain injury).

Dr. Merck's research focuses on neurological emergencies, critical care, resuscitation, cardiac arrest, and COVID pandemic response.

# Assessing Risk in Social, Behavioral, and Education (SBE) Research

HRPP Director Sanjur Brooks, DPS, MS, facilitated a panel discussion of Dr. Robin Everhart's "RVA Breathes" protocol.

The panel presentation focused on the review of this protocol from three distinct perspectives: the Principal Investigator represented by Robin Everhart, Ph.D., the VCU IRB Chair represented by Ronald Evans, Ph.D., and the former VCU reviewer and IRB Analyst represented by Nyssa Towsley, MS, CIP.

The rich discussion provided a rare 360-degree perspective of assessing risk throughout the IRB submission and review process.

#### Required for YOUR Research

If your research involves K-12 settings, the school with which you are working may have certain you must follow in order to conduct research in the school. You may also require a letter of sup prior to initiating your research.
